Terms and Conditions

1. Acceptance of Terms

By purchasing a ticket from Utopia official EU, purchasers agree to abide by these Terms and Conditions. In this document, "purchaser," "ticket holder," or "client" refers to the individual completing the ticket transaction, while "we," "us," "our," and "organizer" refer to Utopia official EU, a legally registered entity in Cyprus (H.E. 461391). Should these Terms and Conditions not be acceptable, we ask that clients refrain from proceeding with any ticket purchases or use of this website.**Ticket Purchase and Payment Policy**

All ticket prices are fixed and non-negotiable. Prices are displayed in Euro (\in), and any changes in price after your purchase will not affect your transaction. You agree that all ticket purchases are final; no exchanges, refunds, or cancellations will be granted unless the event is canceled or rescheduled. If an event is canceled, refunds will be issued to the original payment method, excluding service and booking fees.

Upon successful payment, you will receive an electronic confirmation and a digital ticket. Please ensure all provided information is accurate, as incorrect data may result in denied entry without a refund. 2. Delivery of Tickets

All tickets are delivered electronically to the email address provided during purchase. Once delivered, the ticket(s) become your responsibility, and we are not liable for any loss or damage, including tickets that are stolen, damaged, or lost. Re-issuance requests will be considered at the sole discretion of Utopia official EU and may involve additional fees.

3. Event Access and Identification Requirements

To enter the event venue, you must present a valid ticket along with a government-issued photo ID that matches the name on the ticket. Utopia official EU reserves the right to refuse entry without refund if the ticket holder does not meet the minimum age requirement, appears intoxicated, or fails to adhere to venue policies. All attendees are subject to security screenings, and possession of prohibited items or engaging in unacceptable behavior will result in immediate removal without a refund.

4. Intellectual Property and Usage Restrictions
